## Additional comments:

Finnish institutional innovation support policies analysis from Russian entrepreneurs' perspective is a relevant research topic. Many Russian entrepreneurs in the first decade of our century tried to start technology oriented SME in Finland. So the study how Russian entrepreneurs perceive Finnish institutional environment and innovation support policies provided in the country sounds very promising and thus the topic of the master thesis is actual and up-to-date.

The title, research questions and hypothesis are clearly stated. The work is well-structured and easy to read. Each chapter is followed by precise conclusions that address for the author's development as a professional.

The research of the thesis concentrates on the issue which is rather revelatory by its nature. Theoretical part has close alignment with the practical one. The empirical research of the thesis in the first part is conducted through online questionnaire in order to review the perceptions of Russian entrepreneurs in general. In the second part author investigates the process of establishing the company in Finland.

The author could improve thesis with empirical research of statistical data about Russian entrepreneurs' start-ups in Finland.

Master thesis of Valeria Voltsek meets requirements of MITIM program, and deserves an "excellent" grade in case of successful defense, thus the author can be given the desired degree.
