## Additional comments:

The goal of the study is ascertain the influence of country specific factors on managerial discretion.. There are several questions to the structure of the research:

- it is not obvious that the ownership structure should be considered as a formal institution. Sometimes it is worth to relate this characteristic to the informal institutions (via informal affiliations).
- Table 1 provides information on assessment of impact of national system factor on executive constraint, and it could be interesting to compare differences (or similarities) of given grades for different countries.
- The main findings of the study seem to be quite common, so it is rather difficult to formulate any certain managerial implications on the basis of existing research.
