Additional comments:

Quality of analytical approach and quality of offered solution to the research objectives. In scientific practice the effect of any events usually measured by ESA (event study analysis) method, or CTAR (calendar time abnormal return) method, or Difference-in-Difference method and so on. Using multiple regression is justified only when the cross-country comparisons of companies is made (different taxes, or different degree of regulation of the market of tobacco products, etc.).

Quality of data gathering and description. The choice of GDP or disposable income as independent variables is not correct. The changes of the market value of companies are rather determined by the dynamics of the stock index, i.e. market values of other companies.

Scientific aspect of the thesis. The regression model is built with gross errors. For example: the market value of the company is determined by the total amount of dividends paid by the company, not the amount of the dividend per share. Thus the author does not take into account the total number of company's shares (the regression coefficient is enormous $-3,6 \cdot 10^7$, see for example Table 5 on p.39). Such a model can give incorrect results that meaningless to discuss.

Practical/applied nature of research. "Implementation of tobacco control measures works in favor to companies" — this finding is likely the result of errors of the author's model. The other findings are trivial and well-known.

Master thesis of Nikitina Evgeniya meets the requirements of MCF program, and deserves a "satisfactory" grade, thus the author can be given the desired degree.
