The thesis prepared by A. Bovykin provides contribution to the emergent stream of literature on internationalization of state-owned multinationals from emerging economies. Thesis results demonstrate that state ownership incentivizes acquisition of larger equity share in foreign upstream projects in oil and gas industry. The thesis has a clear structure, research methodology is adequately chosen, research objectives are fully achieved. Thesis layout corresponds to academic standards.

The thesis testifies to strong analytical skills of the candidate, as well as capacity to implement research projects.
