Additional comments:

The presented paper may be considered as a strong research work with a number of strong points:

- The author presents an in-depth critical analysis of literature and develops a novel approach to solve the stated task.
- The methodology is well-described and is supported with strong justification. 2.
- The data collection approach is supported with relevant criteria for events selection, the author carefully identifies not only the overly relevant cases but also those that do not fit the sample due to objective reasons and may be left behind as outliers.
- Empirical analysis is based on data retrieved from a reputable database (Eikon Datastream) which as well supports the quality of estimations.

However, there are several comments that need to be addressed:

- The author states in the paper that the gap is in the "lack in M&A influence model in financial statement analysis approach that could include all factors, considering strategic similarities variable, that affect bank profitability in the context of Russian banking industry." Clarification on whether it is possible to really cover all factors and how this statement is reflected in the research questions and research goal is needed.
- The structure of the work is not fully in line with general research practice: hypotheses statements should originate from the literature review and appear right after the relevant literature analysis. When they are posted in chapter 2, it breaks the logic of discussion and make them seem appearing out of the thin air.

Nonetheless, the overall quality of the work done may be assessed as high.

Master thesis of Mikhail Pashkov meets the requirements of the Master in Management program, and according to the reviewer's opinion deserves a/an "excellent B" grade, thus the author can be given the desired degree.
