Other types of primary sources, namely, official statements by governmental officials are also instrumental in corroborating established media frames to official foreign policy positions adopted by respective governments with respect to the Syrian conflict.

However, what becomes clear from both the literature review section in the Introduction and a number of thesis chapters, is that the author has mastered the literature on conceptual aspects of the problem (elements and strategies of information warfare, strategic communication, etc.), but not – not to the same extent – the literature on the Syrian conflict itself from Political Science and Middle Eastern studies. As a matter of recommendation, a deeper grasp of Syrian social and political dynamics would have allowed for a more accurate picture in terms of the local context. This is the main critical observation on this research which at the same

The author tries to carefully describe her research design in the Introduction – more or less successfully. The application of content analysis in a semi-manual semi-automated way may be evaluated as professional. The amount of work put into this effort must be given a credit.

- 2. Заключение/рекомендации членам ГЭК: Overall, the presented paper constitutes original, coherent, conceptually and methodologically grounded research on a very hot and relevant problem. Bar a certain lack of contextual literature (the one in Middle Eastern studies), it meets all the main requirements associated with graduate qualification papers at the master' level and deserves to be evaluated with the highest 'excellent' grade, while its author deserves to be granted the master's degree in International Relations.
