Additional comments:

Supply chain digitalization is very hot topic for logistics and production companies around the world. Leading companies will have competences in digitalizing their supply chains or already have them. However Russia was slightly behind this process due to lack of infrastructure, both in logistics and IT. Anyways, in order to work in this business, Russian companies will have to go forward with digitalization. From this point of view, it was very interesting to read the paper which compares Russian supply chains with ones in Switzerland. The choice of Switzerland, motherland of some well-known supply chain companies (K+N, for example), was a little bit strange and Germany, the most innovative economy in EU now would be more reasonable, but it is not a critical point for the paper. What is missing from this point of view is the understanding why Switzerland "was chosen a proxy for Western Europe". Russia and Switzerland have probably more differences than similarities: size, economic development, logistics, production and IT development, etc., so it is hard to compare because Russia will never have the same approach as Switzerland.

The structure is clear, coherent. Analytical approaches are appropriate from business point of view. I can't judge research approaches from scientific point of view (the methods look quite scientific and well-articulated), as well as any "scientific aspects of the thesis", but from business point of view, author's point of view is defended. I think for business it is a bit too scientific.

Practical outcomes are quite interesting and useful even for our company. We do see the same trends, however Gabriel was able to put them in a very nice way. The major weakness of the practical conclusions, from my point of view is lack of understanding of specificity of doing business in Russia. This is not the same as in Europe and many of conclusions on how digitalization of supply chains would develop in Russia lacks this understanding. In support of the author I should say that there is no understanding practically nowhere, a great deficit in such kind of research and reports. I wish Gabriel continue his studies and showed us better and more detailed results in future.

Master thesis of Gabriel Gretener meets the requirements of the Master in Management (MIM) program, and according to the reviewer's opinion deserves a/an "good (B)10" grade, thus the author can be given the desired degree.
