Additional comments:

The thesis consists of two chapters where first one is quite deep literature review on different contracts and options. While the literature review is well presented and structured, the author could conduct more analytical study of the literature and may produce comparative table on different contracts for instance. Moreover, the name of the first chapter "Literature review" seems to be inappropriate, as it is too broad and doesn't say anything specific about the content.

The goal of this research is to validate whether or not option contract can coordinate the supply chain better than wholesale purchase contract. To test the hypothesis of the research the author chooses pretty uncommon and new methodology of experimental study.

The strong side of the analysis is that Author provided logical and detailed explanation both of the problem statement and methods chosen for the research. The choice of experimental study as a tool just makes the thesis more interesting.

The overall impression of the thesis is that the thesis follows a logical organization, is generally well structured, all the steps are commented by the Author..

Master thesis of <u>Natalia Kuprenina</u> meets the requirements of the MIB program, and according to the reviewer's opinion deserves a/an "<u>excellent (A)</u>" grade, thus the author can be given the desired degree.
