Additional comments:

The goal of this master thesis is to assess the market perception of mandatory IFRS adoption for listed companies on the basis of historical stock market prices. Objectives were briefly formulated and achieved in a limited way. The research methodology is appropriate. The literature review considered views from a reasonable number of authorities in the field of IFRS. Useful data supported findings. Structure of the thesis corresponds with the research goal and objectives. The relevance of the topic raises some doubts.

Structure of master thesis is logical and designed to achieve the goal stated. There are 2 chapters in the master thesis. The first chapter 1 is devoted to general description of IFRS, current findings on IFRS adoption consequences, and the history of IFRS adoption in Russia. The second chapter includes explanation of applied methodology, description of data sample, variables included into analysis, provides with empirical results, and economic explanation of them.

lakimov Aleksei demonstrated a good effort and interest in the subject. There is a clear evidence of research results. The balanced proportions between the thesis parts were achieved. Research methodology and selected tools appropriate to the objectives. The thesis layout is not in full executed according to MCF program requirements.

However, based on the standard of academic writing practice the thesis has a number shortfalls including:

- The literature review is too descriptive i.e. simply a reproduction of the textbooks and other sources and nothing on personal opinion and critique. The thesis demonstrates a superficial analysis of the problem situation, as well as low quality characteristics of the research object.
- The theory part is poorly structured with limited review of literature on research philosophy and strategies. Such review provides the opportunity for a student to justify appropriateness of chosen research strategies. There is no scientific novelty. Hypothesis artificially invented.
- The data analysis can be improved, the arrangement and presentation of the data analysis is important.
- The text is not formatted in full. Formulas are not numbered. There are grammatical and stylistic errors.
- 5. The managerial application and conclusions are poorly written. All the results of empirical research are not clearly interpretated and can not be used as real steps for managerial decisions. The student focused on analysing results and did not formulate managerial recommendations.

Master thesis of Iakimov Aleksei meets the requirements of MCF program, and according to the reviewer's opinion deserves a "satisfactory/D" grade, thus the author can be given the desired degree.
