<p>Justification of the topic choice. Accuracy in defining the aim and objectives of the thesis. <p>The thesis explored the issues of St. Petersburg ecological policy. The research is in line with popular tendency to consider public policy as the instrument to fit SDG. In order to achieve thesis goal, the issues of the legal framework of environmental policy, current trends and ways of its implementing by means of social marketing mechanisms, have been examined.</p>
<p>Structure and logic of the text flow. Logic of research; full scope of the thesis; alignment of thesis' structural parts, i.e. theoretical and empirical parts.</p>
<p>The aim of the Thesis is to develop a set of measures based on the mechanisms of social marketing to improve the quality of urban policies to combat environmental pollution. To do that an analysis of modern solutions for the implementation of population environmental education was carried out. The priority areas of digital technologies in the framework of policy implementation have been identified and an online-survey of residents of St. Petersburg and Leningrad Region has connected theoretical and empirical parts.</p>
<p>Quality of analytical approach and quality of offered solution to the research objectives. Adequacy of objectives coverage; ability to formulate and convey the research problem; ability to offer options for its solution; application of the latest trends in relevant research are for the set objectives.</p>
<p>In order to fit the aim of the research, the author has selected the appropriate qualitative and quantitative methods. The author combines qualitative research with findings from data collection. The survey permits to identify consumer insights and get answers to some research questions, and the applied cluster analysis allowed to discover 4 clusters with some features and preferences, which formed the basis for recommendations on the development of event programs and the choice of communication channels.</p>
<p>Quality of data gathering and description. Quality of selecting research tools and methods; data validity adequacy; adequacy of used data for chosen research tools and methods; completeness and relevance of the list of references.</p>
<p>In the thesis the collected data have been explored with accuracy and have been used to obtain answers to important for giving recommendations research questions. The literary review was a little bit excessive.</p>
<p>Scientific aspect of the thesis. Independent scientific thinking in solving the set problem/objectives; the extent to which the student contributed to selecting and justifying the research model (conceptual and/or quantitative), developing methodology/approach to set objectives.</p>
