Additional comments:

Having read the master thesis of Anna Kalioshko I had the strong impression of the high quality research paper that is, without any doubt, one of the most excellent qualification papers I have ever seen. This is obviously the result of the thorough investigation of the theme, and at the same time the witness of the extremely high qualification of the author.

that the author do not only presents the scientific results in her thesis, but also deeply discusses and widely interprets her findings, which makes the thesis highly important practically and shapes a series of managerial implications that might be relevant for Russian companies with the interest in the foreign markets.

This is really difficult to pint out some weaknesses or deficiencies in the paper. The only what could be mentioned – this is that the author should shorten the list of theories that she investigates in the theoretical part of the paper. Another suggestion is that it would be better to move some of the statistics from the main body of the thesis to the appendices, which would simplify the reading of the empirical part.

Master thesis of Anna Kalioshko meets the requirements of the MIM program, and according to the reviewer's opinion deserves a/an "excellent (A)" grade, thus the author can be given the desired degree.
