Additional comments:

Key strengths of Elena's master thesis lie both in the solid and comprehensive theoretical review and in the author's empirical research that involves quantitative study. There is a lot of confusion in the literature around the notion of talent management, yet the author systematically analyzed different streams of research and formulated her own vision of this concept. Moreover, it seems to be very interesting to analyze the differences in talent management practices in Russia and Brazil, as both countries are considered to be emerging economies. The empirical part is based on the original questionnaire developed by the author, and contains detailed analysis of the data and thoughtful insights from it. The thesis is written in a logical manner, in a clear and easy-readable yet academic language, which is a good achievement for the master student. The structure of the thesis is clear and logical. I found that the quality of the thesis layout is not very good, the reference list is done using different style for different sources. Despite these critical remarks, the thesis represents an interesting study, and the text provides evidence of the thorough and thoughtful approach of the author who is able to evaluate critically existing literature, formulate clear research questions and systematically work towards finding some answers.

Master thesis of Artyukh Elena meets the requirements of the MIM program, and according to the reviewer's opinion deserves an "excellent (B)" grade, thus the author can be given the desired degree.
