Additional comments:

Strengths:

- (1) Quality of data gathering and description seems to be sufficient for the preparation of the analysis in line with the chosen methodology
- (2) Structure and logic of the text flow is in line with the aim and objectives of the thesis
- (3) The thesis is prepared in line with the requirements for the layout as per Regulations for master thesis preparation and defense

Weaknesses:

- (1) Selection and justification of the topic as well as the purpose of the research remain unclear: the advantages of knowing whether private companies charge more or less for their services as compared with public ones have not been explained
- (2) The conclusions and recommendations of the thesis do not seem to be directly connected to the analysis performed. Based on the undertaken research and its description, it is not obvious, that private companies account for better performance. Since there is no ex-ante and ex-post analysis, it can be the case that private operators have taken over the utilities which were in better condition to begin with. Same applies to the tariffs the wealthier cities are more attractive for the private companies since residents are able to pay more (which is actually confirmed by the analysis presented in the thesis).

Master thesis of $\underline{Viktoriia\ Saplova}$ meets the requirements of the Master of Public Management Program, and according to the reviewer's opinion deserves a " $\underline{good\ C}$ " grade, thus the author can be given the desired degree.
